### Wreck kills two, shuts down Texas 31

Two people were killed and both directions of the four-lane, divided Texas 31 linking Longview with Kilgore were closed Saturday night in a multivehicle

wreck. Department of Public Safety troopers were focused on sorting the wreckage and preventing further catastrophe at 8:45 p.m., less than an hour after they were called to the scene north of the Interstate 20 overpass.

The identities of the victims were unknown, but DPS spokeswoman Jean Dark confirmed the two fatalities. Dark also said both directions of the highway were closed.

No hazardous materials units had been summoned, she added.

### Teacher placed on leave after lecture

A Dallas teacher has been placed on administrative leave after a 12-year-old student recorded him delivering a nearly seven-minute profanity-laced lecture.

KTVT-TV of Dallas-Fort Worth reported the middleschool student played the cellphone recording for her mother Monday after

Besides the profanity in the seven-minute lecture, the teacher refers to his own genitals.

In a Tuesday statement, the Dallas Independent School District said the teacher had been placed on administrative leave after its attorney learned the teacher "may have spoken to students using inappropriate language, tone and behavior during a class recently."

### Man dies in fall from bridge

Fort Worth police say icy conditions were likely a factor when a man fell to his death from an interstate bridge after getting out of his car following an accident in which his vehicle spun out of control.

Officer Daniel Segura says the investigation is continuing, but icy conditions Thursday evening likely contributed to both the man's wreck while traveling eastbound on Interstate 20 and his fall.

The 51-year-old driver crashed into a concrete barrier of the bridge. He then got out of the vehicle and fell off the bridge. He landed on railroad tracks

### Lawsuit claims sex abuse in diocese

A man is seeking over \$1 million in damages in a lawsuit against the Fort Worth Roman Catholic Diocese, alleging he was sexually assaulted by a now deceased priest in the 1990s.

The Fort Worth Star-Telegram reported the man, who now lives near Spokane, Washington, said priest John Sutton was his seventh-grade history teacher at Notre Dame Middle-High School in Wichita Falls.

The lawsuit accuses Sutton of threatening the plaintiff if he told anyone about the abuse. Sutton died in

The suit accuses the diocese and Fort Worth Bishop Michael Olson of "stringing the victim along" to silence him until the statute of limitations ran out. The lawsuit was filed in Tarrant County.

## **UT** Health Northeast to close facilities

Longview, Gladewater clinics will shut down at the end of April

UT Health Northeast officials said patient volumes helped drive decisions to close its Longview and Gladewater clinics at the end of April.

Not including physicians at each clinic, eight people worked at UT Physcians of Longview and UT Physicians of Gladewater.

"Employees at the UT Health Northeast clinics in Gladewater and Longview have been offered positions at other UT Health clinics," said Tim Ochran, chief administrative officer for hospital and clinics. "The physicians will return full time to clinics on our main campus and in Tyler."

A UT Health spokesman said one of the employees decided not to take another position within the system.

UT Health Northeast previously said the decision to close the Gladewater clinic came after the owner of the building where it was located — Continental Realty of Topeka, Kansas — defaulted on its loan and received a foreclosure notice. The clinic was allowed to remain at the location on a month-tomonth basis. With no longterm solution, though, and "lack of the developer's building support," UT Health officials decided to close the clinic.

"Please know that we did not make this decision lightly. UT Health has been a part of Gladewater through the patient care we have provided to its citizens and the community events we support, long before we opened UT Physicians of Gladewater in 2009," said **Executive Vice President** Joe Woelkers.

## Longview temple dedicates state historical marker

Mendy Rabicoff was accustomed to driving to Johnny Cace's Seafood & Steakhouse to borrow chairs when worshippers at Longview's Jewish temple outnumbered places to sit.

That was to be expected on high holy days in past decades, when Temple Emanu-El was the center of a three-city Jewish population.

The temple, aptly situated on Eden Drive in Longview, still is the garden of worship for Jews in Kilgore, Marshall and

its host city. And the unveiling of a Texas Historical Commission marker, beneath the boughs of a double-trunk live oak that might have been a sapling when services began in 1958, opened doors of memories Saturday.

"For 57 years, the members of Temple
